HOW TO SET UP A MONTHLY STANDING ORDER

- Log into your online banking
- Select the option to create a new standing order
- Complete the details as follows:

ACCOUNT HOLDER NAME: Eynsham Primary School PTA

ACCOUNT NUMBER: 08-92-99

SORT CODE: 65756108

AMOUNT: £1, £10, £20 or more ... you decide!

FREQUENCY: Monthly

START DATE: Start on 5th of the month

END DATE: You decide for how long. The control is all yours!

REFERENCE: MD..... Start with "MD" followed by either your name (needed for gift aid) or a random number (anonymous)

CHARITY GIFT AID DECLARATION FORM
